1.1. President's report

February 23, Cassandra and Gerry met with the presidents of some of the west/central community leagues about the proposed infill bylaw changes. At the end of the discussion there was agreement that community leagues were not adequately consulted by the city. We will work together to develop recommendations. The community leagues would like the city to be more collaborative regarding revisions to mature neighbourhood bylaws.

Gerry expressed thanks for the list of maintenance items that Brad has dealt with. There has been significant progress with upgrades to the Rec Centre. (There is still a new floor in the rec centre and a chair rail in in the hall left for the CLIP grant).

He thanked everyone that participated in the Casino on February 20 and 21. We are expecting the money in early April. A special thank you expressed to Christine Worthing for coordinating the casino and volunteers.

Gerry has followed up with AEDs and we will have at least 1 and potentially 2 for the Hall and Rec Centre. There will be training for up to 10 volunteers. They are being provided for free through the Heart and Stroke Foundation.

AGLC for playground status. Stu has completed a letter confirming that the planned new Grovenor playground will be a city playground and is to be maintained by the city. He has sent the letter to his Director to sign.

So far the city has only issued 25% of the CFEP grants that they normally issue. Stu is not sure what is going on with this and why there has been a delay. The grant is a matching grant, and we can use the money from the city for fund matching purposes.

Bike safety program: Saturday June 6. It will be held at the school. Stu will get a poster to us for advertising. It will be either the morning or the afternoon - three hours.

The city is hoping to have the Leaders in Training program information up soon.

New CLIP grant information is now up for the new year (2015).

Stu went to the church to go to the 107th Ave meeting and there were 40 people in attendance. Going forward, they see 107th as staying as a 4 lane road. They are also planning to take out the traffic circle which is one of the highest traffic collision incident locations. They are now looking at making 111th Ave to be a 6 lane road.

Questions: Where at the hall and grounds do we want a mural? – There were two locations agreed on as appropriate (quarter pike backside and on the wall facing skate park).

How much would we want to spend? What subject would we want? Vince to investigate before next meeting.

In the last proposal, the board agreed to purchase the paint and pay a nominal fee to the artist.

There was also discussion about the chance of graffiti on a mural. The answer seemed to be that murals tend to get tagged less. We will also looking into clear coating the mural for protection as well.

Is there any opportunity to get the school involved? Example, having the students paint portions? Or perhaps have the students create some art that the artist can translate into part of the mural.

There is no opposition around the table to having Vince look into a quote for a mural by an artist. He will also follow up with the school to see if they are interested in the project. Timeframe: no specific constraints, but the earlier the better this spring.

1.3. West Central Community Leagues Meeting re bylaw changes Feb 23rd Gerry See president's report.

1.4. Question on politicians advertising in Newsletter

Bill/All

Bill was approached to have political ads in our newsletter. As requested, Gerry approached the EFCL for some guidance on the issue. The EFCL indicated that there were no EFCL policies against this type of advertising and nothing in the applicable legislation for registered NFP community leagues prohibiting this activity. They questioned what our current approved policy was and Gerry indicated we do not have one. They strongly suggested that we develop such a policy and post this for future reference. There is nothing in our bylaws or documentation at AB Registries that prohibits this as well.

There was good discussion about the purpose of the newsletter and what we should have included. Points were made that it is appropriate to have messages from our elected representatives, but perhaps would be a distraction to have partisan ads. Other points were made that a candidate is no different than any other advertiser that requests an ad in the newsletter. Also a suggestion that if we chose to include them, that there should be a clear disclaimer statement that the community league is not involved; that it is a paid political ad and the league does not support any specific candidate or party. There was also an opposite point raised that the newsletter should be for community news and that elections are a community issue.

The main concern around the table would be any perceived partisanship. We need to be perceived as totally unbiased and without any conflict of interest. The majority of Bd members present expressed the opinion that they do not support including

electioneering materials, but that courtesy or thank you messages would be acceptable from politicians within limitations (e.g. maximum ¼ page, in good taste, etc.)

A decision is deferred until next month to allow for some additional analysis.

1.5. Building height bylaws in mature neighbourhoods. The Old Glenora conservation association has requested Grovenor's support to protest a lack of proper consultation on revisions to building codes. The position is that there has been inadequate consultation, from Civics Reps throughout the City. Cassandra is requesting that Grovenor add our name to the list in support for better

There was unanimous support for Cassandra to get involved on behalf of the Community League re this matter.
